Questions received from TLC Diversified - October 5, 2010

Question: 1) In Addendum #2, Question #3, the question asks about detail US10/MC, the answer says to use US-25 on drawing T-04. The problem is that on Drawing C-01 there are two US10/MC, one is an ARV(21) and US-25 is the correct detail, but the other is a PIT(45) and is detailed on Drawing N-08 as specified by the electrical drawings.

Response: The response in Addendum No. 2 was meant to address the ARV only. The PIT as detailed on Drawings E-04 and N-08 remains as is.
