NOTICE OF INTENT TO NEGOTIATE FOR AWARD

The Manatee County Procurement Division provides notice of its intent to negotiate a sole source contract with a value of \$75,039.00 with ASAP Off-Road Specialty Vehicles for the provision of a Medstat utility off-road ambulance.

BACKGROUND/DISCUSSION

Manatee County Procurement Division has completed a due diligence review and intends to procure off-road medical ambulances from ASAP Off-Road Specialty Vehicles without conducting a competitive solicitation process for the following reason(s).

The County has need of off-road medical response ambulances. Vehicle research was conducted by the Public Safety Department with the assistance of Public Works Department's, Fleet Services Division. Multiple vehicle designs were compared and the ASAP Off-Road Specialty Vehicle's units were found to be the only vehicles to meet the County's specifications.

Any company that believes it can provide this good or service must provide, in writing, convincing technical data sufficient to support their position to the Manatee County Procurement Division at purchasing@mymanatee.org no later than January 29, 2021.

Subject: Sole Source Approval Request for ASAP Off Road Specialty Vehicles / Off Road Ambulance

Requisition No:

DEFINITION: Sole Source exists when only one supplier provides the item/service that meets the requirement (e.g., lack of competition or exclusive rights, proprietary technology, copyright or patent, or a supplier's unique capability) NOTE: for the construction materials, modification, alteration or repair of any County-owned facility, the Commission must first make written findings as required by Florida Statute, Section 255.04. Written approval from the county administrator is required for category 4 purchases.

ASAP Off Road Specialty Vehicles is the original equipment manufacturer for the Medstat MS 500 utility vehicle off road ambulance providing sales, service, parts, and warranty.

This equipment has been developed in conjunction between the Public Works/Fleet Division and the Public Safety/EMS operations personel. The ASAP MedStat is the only patented utility vehicle based off-road ambulance.

Justification: (1-2 paragraphs) why the particular service/product is the only type that meets the County's requirements. Include evidence of proprietary rights, patents, supplier is the exclusive distributor or authorized repair/service center, has exclusive territorial rights or unique capabilities (as applicable); any other supporting documentation.

The MS500 off road ambulance are essential to County operations, specifically the Public Safety Department, and are used for patient transport and rescue.

ASAP Off Road Specialty Vehicle is the only manufacturer that builds a fully self contained patient compartment mounted on a utility vehicle chassis - patent #11/185,486.

The MATT - Medical All Terrain Transport is a unique vehicle that is utilized in a variety of operational scenarios. This asset is deployed in environments where a traditional ambulance is unable to operate. An example of these environments include but are not limited to: Covid-19 vaccine support funtions, off road incidents which require the use of an all-terrain vehicle for patient rescue and transportation, large community gatherings such as the Desoto Parade, Manatee County Fair - all require the unit to operate within confined spaces where an ambulance would not be able to access due to size, weight, and terrain.

An internet search of small off road ambulances indicate ASAP Off Road Specialty Vehicles is the only manufacturer of this product. Sole source letter also attached from the vendor.
