The Manatee County Procurement Division provides notice of its intent to award a contract with Energy Resources, Inc. for the provision of Stormwater Discharge Maintenance Program - Lake Brendan Silt Basin.

BACKGROUND/EVALUATION

This project will involve the removal of approximately 11,000 cubic yards of sediment from the drainage system starting at 15th St. E and extending south to Magellan Drive.
