The Manatee County Procurement Division provides notice of its intent to award a contract with Sunshine Dock & Seawall, Inc., for the provision of Boating Safety Buoy Services.

BACKGROUND/DISCUSSION

There are 53 Buoys along the Gulf side of Anna Maria Island and Longboat Key for servicing on an as-needed basis.

The solicitation was advertised on June 10, 2021 on the Manatee County website and Periscope S2G. It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange and Gulf Coast Latin Chamber of Commerce for release to its members.
