The "construction cost estimate" for the automation of the reclaimed water system at the SWWRF is \$865,000 (eight hundred sixty-five thousand dollars) and for the automation of the reclaimed water system at the SEWRF is \$2,071,000 (two million seventy-one thousand dollars).
