### BACKGROUND/DISCUSSION

At the request of the Public Works Department, the Procurement Division issued Invitation to Quote No. 21-R077105SP for the provision of a Stormwater Discharge Maintenance Program for the Morgan Johnson Dredge Project. The work will consist of dredging and removal of sediment from public waterways at the Morgan Johnson location.

The solicitation was advertised on September 3, 2021 on the Manatee County website and the Periscope S2G website. It was also provided to the Manatee County Chamber of Commerce, Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange, and Gulf Coast Latin Chamber of Commerce for release to their members. One response was received from the following firm: Waterfront Property Services, LLC d/b/a Gator Dredging.

#### **EVALUATION RESULTS SUMMARY:**
