

This meeting is to insure that all prospective quoters have sufficient information and understanding of the county's needs.
2. **Quote Due Date is changed to March 4, 2011 at 1:00 P.M.**
2. Enhancements to the County property will not be allowed for this contract, reference page 4, Agreement Terms, last paragraph. Vendor shall be responsible (with no dependence on County electrical or water hookups) for all utilities required for the operation of the concession. Concession must be fully self-contained.
3. Quote request is changed to a Monthly Fee to be paid by the vendor to Manatee County. The percentage request is deleted per the attached revised Quote Form. Note: Food concession and the bait and ice concession are separate venues. Vendor can bid one or both operations at one or more locations.
