The following items represent clarifications, additions, deletions, revisions, and/or modifications to the Contract Documents for the referenced project. This Addendum shall hereinafter be considered full part of the Contract Documents. Receipt of this document must be acknowledged on the Bid Form.

Pertaining to the Specifications:

- Specification 011000-1.5-A-2 shall be revised to read: All rooftop and interior (new and demolition) shall be carried out completely from July 1st through July 29th.
- Specification 01100-1.9-B shall be revised to read: On-Site Work Hours: Limit work in the existing building to working hours of 7:00 a.m. to 6:00 p.m., Monday through Friday. For all work in occupied areas.
- Specification 01740-3.2-D shall be revised to read: Disposal: Transport waste materials and dispose of at designated spoil areas at the contractor's expense.
- Specification 01323-1.3-A shall be revised to read: Photographic Documentation services and all ancillary costs shall be accounted for on the Bid Form under the Bid Items pertaining to the work being documented.
- BID OPENING: March 4, 2011 at 2:00 pm.

Pertaining to Questions and Clarifications:

Question #1: Are we eligible to bid this project with a Class A Air Conditioning license?

Answer #1: We do not see any issues with a Class A Air-Conditioning license contractor bidding this job, providing they have direct experience with this nature of work in size and scope (meet the qualifications). Yes.

<u>Question #2</u>: Is the membrane roof under warranty currently? <u>Answer #2</u>: The Membrane roof is currently under warranty from Peach State Roofing.

Questions #3: Also, in spec section 01323, regarding PHOTOGRAPHIC DOCUMENTATION, the specs read that "Costs For Photographic documentation services are included under the cash allowance for construction Photographic services." Question: Is the cost for this section to be a part of the \$80,000.00 Discretionary Work that is shown and to be added to our proposal amount on the BID FORM?

Answer #3: No, costs for Photographic Documentation shall be included in each Bid Form Item requiring documentation. See above.

<u>Clarification #1</u>: Staging is solely the responsibility of the contractor. Contractor shall make any and all arrangements for staging and any required working space. This facility shall remain functional and operational throughout the entirety of this project. The contractor shall make any effort to accommodate the full use of the facility, grounds and transportation routes, etc.

<u>Clarifications #2</u>: Substitutions: Request for approval of alternate manufacturers not listed as approved equals in the drawings or specifications shall be made in writing no less than ten (10) days prior to bid. Alternate manufacturers not listed as approved equals or basis of design shall not be considered approved to bid unless so stated via addendum. The approval of any substitutions or equals prior to bid shall not be construed as a shop drawing approval. The substitute or equal must be submitted as described in the specifications and meet all the requirements of the specifications and drawings. See Specification 15010 for all requirements for substitutions requests.
