QUESTIONS AND RESPONSES:

Q1. On the plans where the Shared use Path is shown, if the Asphalt is selected as the component, will the Asphalt be carried through the concrete driveways, or will it stop at each driveway and start at the other side of the driveway?

R1. If the asphalt is selected for the shared use path, asphalt will NOT carry through the concrete driveway. Asphalt will stop at each driveway and start at the other side of the driveway.

Q2. Will the county allow asphalt replacement on the Type B stabilization for the Shared use path if the asphalt option is selected?

R2. No.

Q3. Regarding the pay items for MJ Restraints, are these for the bell joint type restraints on the pipe or for the MJ Megalug kits at the fittings, hydrants and valves? Are the pipeline restrained joints incidental to the pipe pay item per LF?

R3. The pay items for MJ restraints are for the amount of bell joint restraints needed to restrain existing pipe per the callouts to restrain some footage of existing pipe seen on the contract drawings and per detail UG-8 on sheet U-46. The mechanical joint kits needed to install valves and fittings as well as the mechanical joint restraint for pipe will be included in the unit price per fitting and unit price per foot of installed pipe respectively. The mechanical joint restraints needed to install the hydrants will be included in each assembly.

Q4. Can the bid date be postponed?

R4. Refer to Change To section of this Addendum No. 1.

Q5. Due to the volatility of the current market, will Manatee County compensate the contractor that is awarded the job for material price increases that may occur between the bid date and date of purchase?

R5. The County intends to award this IFBC at the August 30, 2022 Board of County Commissioners meeting. Bidders should base their bid on a start date of thirty (30) days after award. The County is willing to pay for stored materials and will be encouraging the awarded Contractor to secure approved shop drawings and procure volatile materials as early as possible to avoid material price increases.

NOTE:

Deleted items will be ~~struck through~~, added or modified items will be underlined. All other terms and conditions remain as stated in the IFBC.
