NOTICE OF INTENT TO AWARD A SINGLE SOURCE CONTRACT

The Manatee County Procurement Division provides notice of its intent to award a single source contract with a value of \$36,141.60 with Skyline Network Engineering, LLC for the provision of Streaming Appliance software/hardware assurance, Traveler Information Website (Skyline Public Portal) software assurance, and Stream Manager software assurance renewals for the period October 1, 2022 through September 30, 2023.

BACKGROUND/DISCUSSION

Manatee County Procurement Division has completed a due diligence review and intends to procure Streaming Appliance software/hardware assurance, Traveler Information Website (Skyline Public Portal) software assurance, and Stream Manager software assurance renewals for fiscal year 2023 from Skyline Network Engineering, LLC without conducting a competitive solicitation process for the following reason(s):

- Manatee County procured its RTMC Traveler Information Website from Skyline Network Engineering, LLC in 2017 through Request for Proposals (RFP) No. 17-0272GD. The RTMC Traveler Information Website requires firmware and software updates; security patches; hardware replacements; and support services on an ongoing and as-needed basis.
- Skyline Network Engineering, LLC is the sole organization with the capability to install, configure, start-up, and test the required firmware and software updates; security patches; hardware replacements; and support services. Any work performed by a non-certified Skyline technician will void all warranties.
- Procuring the required firmware and software updates; security patches; hardware replacements; and support services from Skyline Network Engineering, LLC will ensure warranty and compatibility with the County's existing RTMC Traveler Information Website.
- The only alternative to procuring the required firmware and software updates; security patches; hardware replacements; and support services from Skyline Network Engineering, LLC is to procure the goods and services from a different manufacturer, which may require the replacement of the existing RTMC Traveler Information Website, resulting in significantly higher costs with an unknown outcome.
