**NOTICE OF INTENT TO AWARD A SINGLE SOURCE CONTRACT**

The Manatee County Procurement Division provides notice of its intent to award four (4) single source purchase orders with a grand total value of \$463,187.00 with Play Space Services, Inc. for the provision of all labor, equipment, and permitting fees for the installation of custom shade structures at G.T. Bray Park (\$182,440.00), Braden River Park (\$71,135.00), Lakewood Ranch Park (\$146,747.00) and Lincoln Park (\$62,865.00).

**BACKGROUND/DISCUSSION**

Manatee County Procurement Division has completed a due diligence review and intends to procure labor and equipment for the installation of custom shade structures from Play Space Services, Inc. without conducting a competitive solicitation process for the following reason(s):

All the shade structures are being purchased from Advanced Recreational Concepts, LLC (ARC). ARC contracts Play Space Services, Inc. as their sole installer of custom shade designs (in accordance with Manatee County School District Agreement No. 21-0053-MR).

- G.T. Bray Park, Custom Hanging Cantilever Shades (bleacher shade) complete installation services = \$182,440.00
- Braden River Park, "T" Cantilever Shades (bleacher shade) complete installation services = \$71,135.00
- Lakewood Ranch Park, "T" Cantilever Shades (bleacher shade) complete installation services = \$146,747.00
- Lincoln Park, Dome and "T" Cantilever Shades (bleacher shade) complete installation services = \$62,865.00
