EVALUATION SUMMARY:

The Evaluation Committee first convened on May 2, 2023 and conducted technical evaluations of the responsible, responsive, proposals received. The meeting on May 2, 2023 resulted in a unanimous vote to shortlist the seven top-ranked firms. On May 9, 2023, the Procurement Division conducted discussions with the seven shortlisted firms in the form of submitting Requests for Information via email to the seven firms. On May 12, 2023, the Procurement Division provided the Evaluation Committee with each firm's responses to the Requests for Information. On May 16, 2023, the Evaluation Committee reconvened for technical evaluations of the shortlisted firms, which resulted in a unanimous vote to enter into negotiations with the two top-ranked firms: DRMP, Inc. and George F. Young, Inc.
